- 3. Airline and seats must be confirmed while submitting the quotation and submit confirmed Itineraries. If the flight or seat is not available on the above days, you can quote earlier for the earlier date and later for the later date.
- 4. The purchaser reserves the right to reject a bid or all the bids if it is found non-feasible or if we lack the capacity to bear the cost resulting from your early or late quoted dates.
